ELIGIBILITY:

- Developmental Disabilities
- 6-25 years of age.
- Toilet trained. Schedule training not acceptable
- Physically able to participate in active and quiet group activities.
- Will accept those without speech and/or those with controlled seizure.
- Children with severe emotional and/or mental disorders will not be accepted.
- Children with learning disabilities as the primary diagnoses are not appropriate for this program.
- Children must not require one to one supervision (may come with support services; additional fees required for TSS and Support Staff * see below).

REGISTRATION & FEES:

The camp fee will be \$125.00 (\$25.00 non refundable registration/\$100.00 camp fee). If you wish to enroll your child for the 2 - week camping period scheduled for your area, please call the Carousel House after JANUARY 3rd to be put on the waiting list. If there are any openings, you will get a letter with a scheduled appointment for an interview. At the interview, you will know if your child is accepted and will be required to pay a \$25.00 deposit within 2 weeks of the interview. Final payment for all campers will be due by July 28, 2012.

All fees must be paid before your child can attend camp. Trip fee for TSS and support staff - \$25.00.

PLEASE NOTE:

- You may sign your child up for different camp session than you live in but must provide your own transportation.
- Child must wear appropriate attire for active outdoor activities (socks and sneakers).

LUNCH PROVIDED:

- Lunch with Fruit Juice, milk and snacks will be served each day. Ice cream, cake and/or other treats on special days.
- Accommodations will be made for parents who wish to have their children bring lunch to camp.

MEDICAL EXAMINATION REQUIRED:

- To be accepted to camp a medical examination must be completed no more than one year prior to the start of camp. The medical must be submitted by July 28, 2012.
